ORDER:-

In his letter second read above, the Registrar, Tamil Nadu Agricultural University has stated that the following two projects of Tamil Nadu Agricultural University have been approved by the State Planning Commission under Tamil Nadu Innovation Initiatives (TANII) project under second round of sanction for the year 2015-16.

- i. Large Area Impact Demonstration of Fruit Flies Trapping Technology to minimize Yield Losses to Horticulture Farmers in Tamil Nadu - Rs. 245 lakh.
- ii. Integrated Seed Production Hub for Southern Districts of Tamil Nadu - Rs.500 lakh

2. The Registrar, Tamil Nadu Agricultural University has therefore requested the Government necessary orders for Administrative approval and sanction of funds to take up the works according to the technical programme.

3. The Government after careful examination, accept the request of the Registrar, Tamil Nadu Agricultural University, accordingly, Administrative approval is accorded for implementation of the projects mentioned in para 1 above at a total cost of Rs.745 lakh and also sanction is accorded for a sum of Rs. 6,35,05,000 /-(Rupees Six crore thirty five lakh and Five thousand only) towards the implementation of the said projects under Tamil Nadu Innovation Initiatives (TANII) project during the year 2015-16.

4. The amount sanctioned in para 3 above shall be debited to the following head of account.
