ORDER:

In the letter first read above, the Tamil Nadu Energy Development Agency has sent the Solar village proposal under the Tamil Nadu Innovation Initiatives (TANII) under State Innovative Scheme 2015-16. The Irumbai village of Vanur Taluk, Villupuram District has been identified to implement the project 24 x 7 electricity supply. As per the above scheme the Tamil Nadu Energy Development Agency has proposed to instal 170 KWp Grid Connected Solar Photovoltaic Power Plants (Without Battery) at Irumbai village of Vanur Taluk, Villupuram District. The proposed pilot project is expected to demonstrate that rural areas can be provided with 24x7 uninterrupted electricity in a sustainable manner and will therefore act as a model that can be implemented on a large scale. This project comes under Renewable Energy domain. This 170 KWp SPV power plant will operate only during day time (8 hrs per day and 300 days per annum). The total cost of Rs.229.33 lakhs is to be funded from the Innovative Fund.

2) In the letter second read above the State Planning Commission has accepted the above proposal in principle subject to the condition that 10% of the total project cost has to be contributed by the Local Body and any village can be selected by Tamil Nadu Energy Development Agency in consultation with Rural

Development Department on pilot basis. The details of implementation are as follows:-

3) The Government Sanction a sum of Rs.206.10 lakhs (Rupees Two Hundred and six lakhs and ten thousand only) for the installation of 170 KWp Grid Connected Solar Photovoltaic Power Plants at Irumbai village of Vanur Taluk in Villupuram District for (24x7) Uninterrupted Electricity Scheme under State Innovation Fund. Further, 10% of the project cost should be contributed by the Local Body. The proposed expenditure will be met from the existing BE 2015-16 provision.

4) The expenditure sanctioned in para 3 above shall be debited under the following head of account:-

2810 – NEW AND RENEWABLE ENERGY -02-Solar – 800 – Other Expenditure – JA – Installation of 170 KW grid connected Solar Power Plant at Irumbai village of Vanur Taluk in Villupuram District for (24x7) Uninterrupted Electricity Scheme under State Innovation Fund – 09 – Grants-in-Aid-03 Grants for specific schemes .
