ORDER:

In the letter first read above, the Member Secretary, State Planning Commission has approved the Scheme Seri-Tourism under State Innovation Fund for the year 2015-2016 and also recommended to sanction a sum of Rs.250.00 lakh.

2. In the letter second read above, the Director of Sericulture has stated that by promoting Silk farm as a tourist centre, more number of public / farmers will visit the place and come to know about Sericulture sector, which is an important agro economic activity. This will also help the local tribals to interact with tourists which will help them for their social and economical upliftment. Seri-Tourism is the promotion of tourism, coupled with creation of awareness to the tourists about the Sericultural activities right from mulberry cultivation to silk fabrics. It is proposed to develop Government Silk farm, Yercaud as an "Exhibition cum Demonstration Centre" with all Sericultural activities including Silkworm seed production, Mulberry cultivation, Silkworm rearing, Silk reeling, Silk weaving etc. It includes establishment of model mulberry plots, Establishment of Children's park, Lawns, exhibition, Children's animation centre, establishment of model silk reeling unit, twisting unit, weaving unit, establishment of civic amenities etc., at a total cost of Rs.250.00 lakh as follows:-

3. The Director of Sericulture has requested to sanction a sum of Rs.2,50,00,000/- (Rupees Two Crore and Fifty lakh only) under "State Innovation Fund" towards Seri-Tourism for the year 2015-2016.

4. The proposal of the Director of Sericulture has been carefully examined by the Government. Accordingly, sanction is accorded for a sum of Rs.2,50,00,000/- (Rupees Two crore and Fifty lakh only) towards Seri-Tourism of Department of Sericulture under Tamil Nadu Innovative Initiatives Schemes for the year 2015-2016.

5. The expenditure sanctioned in para 4 above shall be met from the State Innovation Fund and debited to the following Head of Account:-


