ORDER:

In the letter first read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that Sportspersons of today require consistent and rigorous scientific training of the highest quality standards to compete at the International level events. Many of our sportspersons are not able to reach top levels consistently due to lack of proper scientific training. If their dreams have to be realized, it is important that we lay the foundation for the scientific assessment and enhancement of sports activities. Sports Medicine has come a long way as a discipline offering valuable service in understanding, predicting and influencing human behavior in physical activity and sports. Sports Medicine specialists are serving as consultants, counselors, performance enhancers or educators to provide scientific input to the elite and budding sportspersons. Sports scientists are involved in Sports Psychology, Sports Physiology, Sports Nutrition, Sports Biomechanics, Training Methods, Rehabilitation and Research. The developed countries like USA, Europe have integrated the Sports Science with Sports and are reaping the rich dividends by winning medals and laurels in the World Sports.

2. The main objective of Integrated Sports Science Centre are:-

- Prevention of sports related injuries

- Rehabilitation of an injured sportsperson and to restore his original physical fitness so that he can resume sports activities at the earliest.
- Promotion of Drug free Sports

In order to improve the performance and to rehabilitate the athletes performance by treating in the correct path by the way of providing medical, physical and psychological training, it is proposed to create the International standard Integrated Sports Science Centre at Madurai.

3. Subsequently, this scheme was announced by the Hon'ble Chief Minister under Rule 110 in Tamil Nadu Legislative Assembly during Budget Session 2015-16.

4. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction a sum of Rs.924.00 lakhs for establishment of Integrated Sports Science Centre at Madurai.

5. The Government after careful consideration, sanction a sum of Rs.500.00 lakhs (Rupees five hundred lakhs only) as non-recurring grant for establishment of International level Integrated Sports Science Centre at Madurai under State Innovation Fund of Tamil Nadu Innovation Initiatives (Part-II Schemes) Schemes for the year 2015-16.

6. The expenditure sanctioned in para 4 above should be debited under the following head of account.

2204 - 00 Sports and Youth Services - 104 – Sports and Games – Schemes in the Twelfth Five Year Plan –II. State Plan – KW Establishing Integrated Sports Science Centre at Madurai – Scheme under State Innovation Fund – 09 Grants-in-Aid – 02 – Grants for Creation of Capital Assets.

7. The above expenditure shall be met from the State Innovation Fund by deducting under the following head of account.

2204 – 00 Sports and Youth Services – 902 Deduct – Amount from State Innovation Fund – JB Deduct – Amount met from State Innovation Fund – 30 Inter Accounts Transfers.

And contra debiting J Reserve Fund (b) Reserve Funds not bearing interest – 8229 00 Development and Welfare Funds – 200 Other Development and Welfare Funds – BE State Innovation Fund.

8. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development

Department. The amount sanctioned above shall not be paid in cash but shall be credited into following head of account by means of cheque.

"K. Deposits and Advances – (B) Deposits not bearing Interest – 8443 – 00 Civil Deposits – 800 Other Deposits – CH Deposits of Sports Development Authority of Tamil Nadu" (DPC 8443 00 800 CH 000D) " by means of a cheque / demand draft drawn in favour of Sports Development Authority of Tamil Nadu **P.D. A/C No.6184513932.**

9. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government at the appropriate time.
