Government Letter No.1665/ST-2&E/2015, Dated: 05.11.2015

In the Budget Speech, 2015-2016 the Hon'ble CM has made an announcement that, this Government proposes to establish a Data Analytics Unit as a collaboration between Department of Economics and Statistics and the Tamil Nadu e-Governance Agency to analyze, in real time, the large volume of data available with the Government to enable improved policy making for better service delivery. Tamil Nadu will be the first state to establish such unit.

2. In the reference first read above, the Government issued orders for setting up of Steering Committee under the Chairmanship of Principal Secretary to Government for approving the proposal of the cell/ Data Analytical Unit and monitor of the progress of the proposals in this regard.

3. In the Government Letter second read above, the Principal Secretary/ Commissioner, Department of Economics and Statistics was instructed to apply State Planning Commission for funding to establish the Data Analytics Unit under the Tamil Nadu Innovative Initiatives (TANII). Accordingly, a proposal for the activities of the Data Analytics Unit to be operationalized in two phase under TANII at a total cost of Rs.428.66 lakhs, was sent to State Planning Commission for funding.

4. The proposal has been appraised by the State Planning Commission. Tamil Nadu being the first State to establish such a unit, and the unit is to attempt to provide solutions to most of the decision making problems, and therefore the State Planning Commission has recommended the proposal for funding under TANII for the year 2015-16. The ultimate cost of the project recommended by SPC for two phases is Rs.428.66

lakhs and the cost of the project approved for the first phase activities of the Data Analytical units is Rs.63.00 lakhs.

5. The Government after careful consideration accord sanction for a sum of Rs.428.66 lakhs (first year Rs.63.00 lakhs + Second year Rs.365.66 lakhs) and release a sum of Rs.63.00 lakhs for the year 2015-2016 for operationalizing first phase activities for the Data Analytics Unit.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

3454. Census, Surveys and Statistics 02. Surveys and Statistics 110. Gazette and Statistics memoirs JZ. Operationalizing for first phase activities of the Data Analytical Unit – Scheme under State Innovation Fund 09. Grants-in-Aid 03. Grant for specific schemes (DPC 3454 02 110 JZ 0931).


