### ORDER:-

In the letter third read above, the Director of Agriculture has sent the proposal for On-farm soil fertility enrichment in sugarcane fields using Bio-mineraliser at a cost of Rs.50.00 lakhs. The Director of Agriculture has stated that in Tamil Nadu, Rice and Sugarcane are the predominant crops grown in an area of about 21 L.Ha. Nearly, 21 million metric tonnes of crop residue are produced annually. A major portion of these agricultural waste is disposed only by burning in the crop fields which is not the right way as it pollutes the environment, the rests are left in the field. The use of eco-friendly, low cost, renewable input viz., Bio-mineraliser, a microbial consortia plays a vital role in re-cycling and re-use of the crop residues which in turn enriches the soil fertility and creates a conducive environment for organic cultivation. The scheme would be implemented in 7 districts viz., Cuddalore, Villupuram, Vellore, Thiruvannamalai, Namakkal, Dharmapuri and Erode on a pilot basis covering an area of 5000 ha benefitting 5000 farmers.

2. Hence, the Director of Agriculture has requested to sanction this scheme at a total cost of Rs.50.00 lakhs and to authorize him to draw and incur the expenditure for the implementation of the scheme 2015-2016.



3. The Government after careful consideration accept the proposal of the Director of Agriculture and sanction a sum of Rs.50.00 lakhs (Rupees fifty lakhs only) for On-farm soil fertility enrichment in sugarcane fields using Bio-mineralizer as detailed below:-

4. The Director of Agriculture is authorized to draw and disburse the amount sanctioned at para 3 above for implementation of the above said scheme.

5. The amount sanctioned on para 4 above shall be met from the State Innovation Fund and debited to the following head of account:-
