### ORDER:

The Commissioner of Tamil Nadu Archives and Historical Research has submitted the proposal for Implementation of scheme of "Improving Web Access to the Digitalised Records" which involves hosting of the digitised records of the Tamil Nadu Archives in it's website. It also involves linking the Tamil Nadu Archives to TANSWAN to enable access by Tamil Nadu Archives of the data base located at ELCOT's Data Centre. The proposal also proposes provision of computer systems and peripherals for all it's stacks over LAN network, for providing improved services to researchers and public seeking information / public records that are yet to be digitised.

2. In the letter second read above the Commissioner of Archives and Historical research has stated that the project proposal "Improving Web Access to the Digitalised Records" has the following three components which have been recommended by the State Planning Commission under State Innovation Fund over two years, 2015-16 and 2016-17, with allocation of Rs.30.00 lakh and Rs.37.00 lakh respectively.

3. The Commissioner of Archives and Historical Research has requested permission of the Government for implementation of the scheme "Improving Web Access

to the Digitalised Records" through ELCOT, Tamil Nadu E-Governance Agency and PTCS as may be necessary and procurement procedures prescribed in Tamil Nadu Transparency in Tender Act and Rules will be followed.

4. The Government after careful consideration, sanction a sum of Rs.30.00 lakhs(Rupees thirty lakhs only) for implementation of the scheme of "Improving Web Access to the Digitalised Records" under TamilNadu Innovation Initiatives Schemes(TANII) for the year 2015-2016.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account :-

"2205 – 00 Art and Culture – 104 Archives – Schemes in the Twelfth Five Year Plan - II.State Plan – JG Improving the web access to the digitalised records of the Tamil Nadu Archives – Scheme under State Innovation Fund – 76 Computer And Accessories – 01 Purchase." (DPC:2205 00 104 JG 7618)

6. The above expenditure shall be met from the State Innovation Fund by deducting under the following head of account:-

"2205 – 00 Art and Culture – 902 Deduct – Amount met from State Innovation Fund – Schemes in the Twelfth Five Year Plan – II.State Plan – JA Deduct – Amount met from State Innovation Fund – 30 Inter Accounts Transfers." (DPC:2205 00 902 JA 3005) and contra debiting:

"J Reserve Fund (b) Reserve Funds not bearing interest – 8229 00 Development and Welfare Funds – 200 Other Development and Welfare Funds – BE State Innovation Fund." (DPC:8229 00 200 BE 0006) (outgo)

7. The Commissioner of Archives and Historical Research is authorised to draw and disburse the amount sanctioned in para-4 above to the implementing agency and procurement procedures prescribed in Tamil Nadu Transparency in Tender Act and Rules should be followed.
