ORDER:

In Government Order first read above, the Government accorded administrative sanction for a sum of Rs.85,25,000/- for implementation of “Installation of Facial Recognition System for Secretariat” under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2017-2018 (Round-II) subject to condition that;

- (i) The expenditure has to be incurred only for the purpose sanctioned by the State Planning Commission.
- (ii) Unspent/Savings amount, if any, has to be surrendered to Government account.

2. The Director General of Police in his letter second read above, has sent the proposal to the Government seeking Administrative and Financial sanction for a sum of Rs.85,00,000/- towards the purchase of IP based day and night PTZ Speed Doom Cameras and fixed cameras with accessories for the provision of IP based surveillance system at Secretariat.

3. The Government in its letter third read above has stated among others and requested the Director General of Police to integrate the proposals as stated in paragraph 1 and 2 above and to send the proposal afresh to Government for consideration.

4. The Government in the letter fourth read above has requested the Director General of Police, Chennai to send the detailed proposal for "Secretariat Surveillance System" along with Appraisal Format in the prescribed format to the State Planning Commission for inclusion in the ensuing Tamil Nadu Innovation Initiatives, 2019-2020 (Second Round), State Planning Commission's Appraisal Meeting under intimation to Home Department. Consequently, the Director General of Police, Chennai has forwarded the detailed proposal to the Member Secretary, State Planning Commission, Chennai.

5. The Director General of Police, Chennai in his letter sixth read above has stated among others that during the discussions held on 06.10.2020 at State Development Policy Council (SDPC) (erstwhile State Planning Commission) to review the Tamil Nadu Innovation Initiatives Schemes, State Development Policy Council has requested the Police Department to address the Government to cancel the Government Order first read above, so that the funds may be redirected to some other projects. He has therefore requested the Government to cancel the aforesaid Government Order.

6. The Government after careful examination decided to accept the proposal of the Director General of Police and ordered that the Government order first read above is hereby cancelled.
