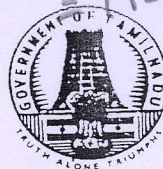

ORDER:

In the letter first read above, the Additional Chief Secretary/Commissioner of Land Administration has stated that the processes of Land Acquisition are done manually in the present system and this make it difficult to track the process of the Land Acquisition processes. There is no credible MIS system for analyzing the delays in Land Acquisition process for all infrastructure projects of Government or its agencies. Therefore, in order to overcome these challenges Land Administration Department has proposed "computerization of Land Acquisition process under" TANII at a total outlay of Rs.113.00 lakhs. The project is to develop a software application with online facility to cater the components of land acquisition process.

2. The State Planning Commission has approved the proposal of Chief Secretary/Commissioner of Land Administration for sanction of Rs.98 lakhs for computerization of land acquisition process in the Land Administration Department under the Tamil Nadu Innovation Initiatives Scheme (TANII) for the financial year 2017-2018.

3. During the Budget session 2017-18, the Hon'ble Minister (Revenue) has made an Announcement that an Integrated work Flow system for land administration will be created to design, develop and implement an end-to-end work-flow based online system for all business processes by creating integrated portal for review of patta transfer application and corrections then and there by Commissionerates of the Land Administration, Land Reforms and Survey and Settlement converge on the Land Records database (Tamil Nilam) at a cost of Rs.1.38 cores which includes Rs.98 lakhs as approved by the State Planning Commission. The Additional Chief Secretary/Commissioner of Land Administration in his letter first read above has recommended that for development of an integrated portal for Land Administration/ Land Reforms/ Survey and Settlement and citizen services for Patta Transfer Appeals and Revisions, the remaining funds of Rs.40 lakhs for this component may be provided from Digital India Land Records Modernization Programme (DILRMP) scheme, administered by Director of Survey and Settlement. Accordingly, the Director of Survey and Settlement is instructed to take necessary action for sanction and release of Rs.40 lakhs from Digital India Land Records Modernization Programme (DILRMP) Scheme.

4. Accordingly the Government hereby accord sanction for a sum of Rs.98.00 lakhs (Rupees Ninety Eight Lakhs only) for the computerisation of the land acquisition process in the Land Administration Department under the Tamil Nadu Innovation Initiatives Scheme (TANII) for the financial year 2017-2018.

5. The expenditure sanctioned in paragraph 4 above shall be debited to the following head of account:-

"2029-00 LAND REVENUE -001 Direction and Administration - State's Expenditure - JC Computerization of Land Acquisition- Scheme under State Innovation Fund - 76 Computer and Accessories - 01 Purchase

(DPC:2029 00 001 JC 7618)"

6. The above expenditure shall be met from the State Innovation fund by deducting under the following head of account.

"2029-00 Land Revenue - 902 Deduct - Amount met from State Innovation Fund - State's Expenditure - JC Deduct - Amount met from State Innovation Fund - 30 Inter-Account Transfers

(DPC:2029 00 902 JC 3005)"

And contra debiting

... Fund (b) Reserve funds not bearing interest - 8229-00. Development funds - 200. Other Development and Welfare Funds - BE. State Innovation

7. The Additional Chief Secretary/Commissioner of Land Administration is authorised to draw and disburse the amount sanctioned in para 4 above and Additional Chief Secretary/Commissioner of Land Administration shall ensure that this scheme shall be implemented in the current financial year 2017-18 and should send the completion report of the above scheme to the Government.

8. The Pay and Accounts Officer concerned is requested to open a new head of account in his books.

9. The Accountant General of Tamil Nadu is requested to make necessary book adjustment regarding the drawal of funds from the State innovation fund account.
