ORDER:-

The Principal Chief Conservator of Forests has sent a proposal in the references first and third read above for the scheme "Tribal Eco Cultural Village – A living museum in Sahyanamangalam Division, Sathyamangalam Tiger Reserve, Erode" and requested the Government to sanction an amount of Rs.700 lakh under TANII - State Innovation Fund for the year 2018-2019 (Round-I).

2. In the letter second read above the State Planning Commission has recommended this scheme with staff cost. Accordingly, the assistance arrived under TANII is Rs.700 lakh as follows:-

3. The Hon'ble Chief Minister under Rule 110 has made the following announcement on the floor of assembly on 01.06.2018:

“தமிழ்நாட்டில் உள்ள பழங்குடியின மக்களின் கலாச்சாரம் மற்றும் சூழல் நட்பு வாழ்க்கையை அடையாளம் கண்டு, அவர்களின் கலாச்சார வளமையை மேம்படுத்தவும், இயற்கை நட்பு வாழ்க்கை முறையைத் தெரியப்படுத்தவும், ஈரோடு மாவட்டத்தில் உள்ள சத்தியமங்கலம் புலிகள் காப்பக புற எல்லைப் பகுதியில் அருங்காட்சியகம் மற்றும் பழங்குடியினர் சூழல் கலாச்சார கிராமம் ஒன்று 7 கோடி ரூபாய் செலவில் உருவாக்கப்படும். இது தமிழ்நாட்டிலுள்ள பழங்குடியின மக்களின் சமூக பொருளாதார வளர்ச்சியை பெரிய அளவில் ஏற்படுத்தும் என்பதை மகிழ்ச்சியுடன் தெரிவித்துக் கொள்கிறேன்”.

4. The Government after careful consideration, accept the proposal of the Principal Chief Conservator of Forests and Chief Wildlife Warden and accord sanction for a sum of Rs.700 lakh (Rupees Seven Crore only) for Tribal Eco Cultural Village Sathyamangalam Tiger Reserve in Erode under State Innovation Fund during the year 2018-2019 as annexed to this order.

5. (i) The expenditure sanctioned in para-4 above shall be debited to the following head of accounts:-

“2225 WELFARE OF SCHEDULED CASTE, SCHEDULED TRIBES, OTHER BACKWARD CLASSES AND MINORITIES – 02 Welfare of Scheduled Tribes. 796 Tribal Area Sub-Plan – JZ Tribal Eco Cultural Village – A living museum in Sathyamangalam division, Erode under State Innovation Fund – 09 Grants-in-Aid – 03 Grants for Specific Schemes

(DPC – 2225 02 796 JZ 0938)”

(ii). the expenditure shall be met from the State Innovation Fund by deducting under the following head of account:-

“2225 WELFARE OF SCHEDULED CASTE, SCHEDULED TRIBES, OTHER BACKWARD CLASSES AND MINORITIES – 02 Welfare of Scheduled Tribes – 902 Deduct – Amount met from State Innovation Fund. State's Expenditure – JA Deduct – Amount met from State Innovation Fund. 30 Inter-Account Transfers

(DPC – 2225 02 902 JA 3009)”

And Contra – debiting the following fund account:-

“J- Reserve Fund – (b) Reserve funds not bearing interest – 8229 00 – Development Welfare Funds – 200. Other Development and Welfare Funds – BE State Innovation Fund

(DPC – 8229 00 200 BE 0006) (Outgo)

6. Necessary funds are provided in the Budget Estimates 2018-2019.

7. The Principal Chief Conservator of Forests is authorized to incur the expenditure sanctioned in para-4 above. He is also requested to ensure that the amount released therein is utilized in full and to send the utilization certificate as soon as the work is completed.
