ORDER:

In the letter 1st read above, the Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency has requested for sanction of a sum of Rs.296.80 lakh for the design, development and management of Unified Content Management and Portal Framework for Government of Tamil Nadu under TANII 2017-18 (second round) Fund for managing the unified portal by the user departments and facilitate a uniform method of dissemination of information for the citizens.

- 2. In the letter 2nd read above, the Member Secretary, State Planning Commission (SPC) has informed that the proposal has been approved by the State Planning Commission for funding under TANII Scheme for the year 2017-18 (second round) at a reduced outlay of Rs.81.50 lakh for one year only.
- 3. The Government after careful examination accord sanction for a sum of Rs.81,50,000/- (Rupees eighty one lakh and fifty thousand only) for the project "Unified Content Management System and Portal Framework for Government of Tamil Nadu under Tamil Nadu Innovation Initiatives Schemes for the year 2017-2018.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:
