ORDER:

In the letter third read above, the Principal Resident Commissioner, Tamil Nadu House, New Delhi has sent five proposals for consideration under the Tamil Nadu Innovation Innovative Scheme for financial support in "State Innovation Fund" for the year 2018-2019 (Round -1).

- 2. The State Planning Commission has recommended four proposals of the Principal Resident Commissioner, Tamil Nadu House, New Delhi for assistance under TANII, (i.e) (i) Provision of Hospitality Kiosks at Vaigai Tamil Nadu Illam and Podhigai Tamil Nadu Illam, (ii) Fleet Management System with Tracking & Navigation facility, (iii) Modernization of Kitchen with modern Kitchen Equipment at Vaigai Tamil Nadu Illam (iv) Recreation facilities for Children and Guests at Vaigai Tamil Nadu Illam and Podhigai Tamil Nadu Illam Campus for the year for the year 2018 2019 (Round I). The State Planning Commission has also requested to issue necessary sanction as per the guidelines and procedures prescribed in the reference first and second read above after obtaining the detailed proposals from the Head of Departments.
- 3. The Government therefore accord administrative and financial sanction for a sum of Rs.1,13,10,000/- (Rupees one crore thirteen lakh ten thousand only) towards the expenses as detailed below:
