In the letter second read above, the Director, State Council of Educational Research and Training has submitted the proposal on "Teacher Training Programme for Identification and Remedial Education for Specific Learning Disability to Tamil Nadu Government School Children and follow up mechanism of Orientation and SLD for all teachers in each Block" under Tamil Nadu Innovation Initiatives for the year 2018-2019 and requested to sanction a sum of Rs.19.15 lakhs for the scheme.
