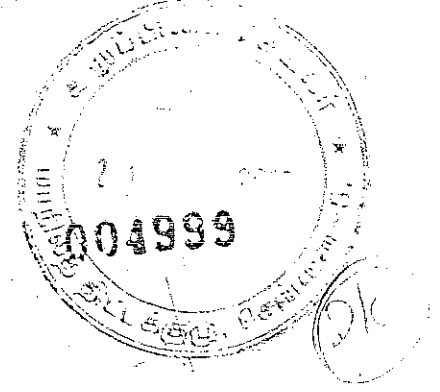



2. From the Director cum Mission Director, Integrated Child Development Services Scheme Letter Roc No. 14453/NMP/2016, dated 21.03.2017.
3. From the Commissioner of Social Welfare Letter No.8819/NMP2/2017 dated 16.02.2018, 02.03.2018, 21.03.2018, 03.05.2018, 12.07.2018, 23.10.2018 and 09.11.2018.

ORDER:

In the letter first read above, the Tamil Nadu State Planning Commission has recommended among others for the Introduction of Iron Fortified Rice in PTMGR Nutritious Meal Programme and Integrated Child Development Services Scheme in the State of Tamil Nadu at a cost of Rs.529.25 Lakh (i.e.) Rs.341.83 Lakh and Rs.187.42 lakh for the years 2018-2019 and 2019-2020 respectively under TANII.

2. The Commissioner of Social Welfare in the letters third read above has sent a detailed proposal under TANII for the year 2018-2019 for introduction of Iron Fortified Rice with 9 nutrient contents viz Vitamins A, B1, B2, B3, B6, B12, Folic Acid, Iron and Zinc, in PTMGR Nutritious Meal Programme and Integrated Child

Development Services Scheme in 5 Districts namely, Dharmapuri, Madurai, Thoothukkudi, Thanjavur and The Nilgris and requested the Government to accord sanction for a sum of Rs.163.40 Lakh and Rs.289.33 Lakh to implement the scheme during the years 2018-2019 and 2019-2020 respectively under the relevant head of accounts.

3. After detailed examination of the proposal of the Commissioner of Social Welfare, the Government accord sanction for an amount of Rs.122.35 lakh towards recurring expenditure and an amount of Rs.41.05 lakh towards non-recurring expenditure totaling a sum of Rs.163.40 Lakh (Rupees One Crore Sixty Three Lakh and Forty thousand only) for the implementation of Iron Fortified Rice with 9 nutrient contents viz Vitamins A, B1, B2, B3, B6, B12, Folic Acid, Iron and Zinc, in PTMGR Nutritious Meal Programme and Integrated Child Development Services Scheme in 5 Districts namely Dharmapuri, Madurai, Thoothukudi, Thanjavur and The Nilgris under TANII scheme for the year 2018-2019.

4. The amount sanctioned at Para 3 above shall be debited by re-appropriation from the head of account " 2236 02 102 KY 0935 " to the heads of account as detailed below:-

5. Necessary additional funds will be provided in Revised Estimate/Final Modified Appropriation 2018-19 to meet the expenditure sanctioned in para-3 above by way of re-appropriation as detailed in para-4 above. Pending re-appropriation of such funds, the Commissioner of Social Welfare is authorized to incur the expenditure

sanctioned in Para 3 above. The Commissioner of Social Welfare is also requested to include the expenditure while sending the proposal for RE/FMA 2018-19 to Government in Finance (SW) Department without fail.

6. The Commissioner of Social Welfare is directed to procure the FRK (Fortified Rice Kernel), Machineries and equipments by strictly following the Tamil Nadu Transparency in Tenders Act, 1998 and Rules, 2000 there under. The Commissioner of Social Welfare is also directed to incur the expenditure towards blending operations (Maintenance and Labour) through the Tamil Nadu Civil Supplies Corporation.

7. The Commissioner of Social Welfare is also requested to maintain separate and proper accounts for the amount received and not to divert the grant for any other purpose at any cost.

8. The Commissioner of Social Welfare shall furnish the progress report as well as utilization certificate for every quarter to the Government at appropriate times.

9. This order issues with the concurrence of Finance Department vide its U.O.No.62440/Fin(SW)/2018 dated 13-12-2018 ASL No.2248 (Two thousand two hundred and forty eight).


