From the Deputy Director General, National Cadet Corps, Chennai, Letter No.1456/SC/TANII, dated 8.12.2017.

ORDER:

In the letter read above, the Deputy Director General, National Cadet Corps has stated that National Cadet Corps Directorate, Tamil Nadu with over One Lakh Cadets is the third largest Directorate at the country covering over 360 colleges and 820 schools across the State. He has further stated that 5 NCC Group Headquarters (ie. 2 at Chennai, 1 each at Thiruchirappalli, Madurai and Coimbatore) are functioning in Tamil Nadu under the control of National Cadet Corps Directorate. However, 51 NCC units in various districts of the State affiliated with the NCC Gp Headquarters are covering National Cadet Corps activities in the affiliated colleges and schools.

2. The Deputy Director General, National Cadet Corps has also stated that as part of the curriculum, National Cadet Corps Cadets are required to attend camps conducted by their respective NCC units. On an average 500 National Cadet Corps Cadets attend training camp at 10-12 days duration. While built up accommodation is provided to the cadets in the camp, in some of the camps accommodation in tents is also provided to the SD / JD cadets, due to paucity of space. The sanitation for the cadets is one of the major challenges faced by the National Cadet Corps while conducting camps. As there is possibility of health issues, if no proper sanitation is maintained in camps. It is proposed to establish Portable Bio Toilets in selected camps as pilot project. Therefore, in order to overcome this challenge it is proposed to use Bio-Toilets camps to improve the sanitation, aiming to avoid the diseases on account of poor sanitation.

- 3. The Deputy Director General, National Cadet Corps has requested the Government to accord financial sanction under Tamil Nadu Innovation Initiatives 2018-19 for establishment of 4 Portable Bio-Toilet units in each of the 5 NCC Group Headquarters (2-Chennai, 1 each at Thiruchirappalli, Madurai and Coimbatore) of the State for the use of National Cadet Corps Cadets in NCC Camps for a sum of Rs.20.00 lakhs at the earliest.
- 4. The Government after careful examination sanction a sum of Rs.20,00,000/- (Rupees Twenty Lakhs only) as non-recurring expenditure to the National Cadet Corps Directorate towards establishment of 4 Portable Bio-Toilet units in each of the 5 NCC Group Headquarters (2-Chennai, 1 each at Thiruchirappalli, Madurai and Coimbatore) (Totally 20 Nos. of Bio-Toilets) for the use of National Cadet Corps Cadets in NCC Camp under Tamil Nadu Innovative Initiatives for the year 2018-19.
- 5. The expenditure sanctioned in para-4 above shall be debited under the following Head of account:

"2204-00 Sports and Youth Services – 102 Youth Welfare Programmes for Students – State's Expenditure – JF Establishment of Portable Bio Toilets for the use of NCC Cadets during camps under State Innovation Fund – 47 Stores and Equipments – 02 Equipments." (DPC 2204 00 102 JF 4725)

6. The above expenditure shall be met from State Innovation Fund by deduction under the following head of account:

"2204-00 Sports and Youth Services - 902 Deduct - Amount met from State Innovation Fund - State's Expenditure - JA Deduct -Amount met from State Innovation Fund - 30 Inter - Account Transfers." (DPC 2204 00 902 JA 3006)

"J Reserve Fund (b) Reserve Funds not bearing interest – 8229 00 Development and Welfare Funds – 200 Other Development and Welfare Funds – BE State Innovation Fund."

7. The Deputy Director General, National Cadet Corps is the estimating, reconciling and controlling authority for the above new head of account.

- 8. The Deputy Director General, National Cadet Corps is authorized to draw and disburse the amount sanctioned in para 4 above. The Deputy Director General, National Cadet Corps shall send the detailed expenditure report, utilization certificate etc., to the Government at the appropriate time.
