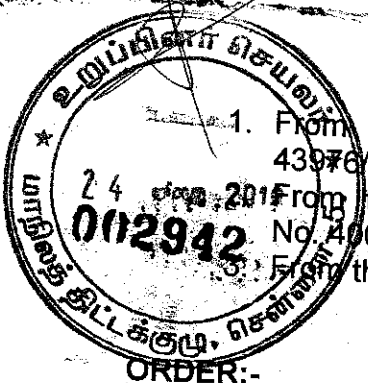

ORDER:-

The Principal Chief Conservator of Forests has sent the proposal in the reference first and third read above for establishment of an “Orchidarium” in Anamalai Tiger Reserve and requested the Government to sanction an amount of Rs.46.90 lakh under TANII - State Innovation Fund for the year 2018-2019 (Round-I).

2. In the letter second read above the State Planning Commission has recommended this scheme without recurring cost at an outlay of Rs.46.90 lakh for assistance under TANII as follows:-

3. The Hon'ble Minister (Forests) has made the following announcement on the floor of Assembly on 29.05.2018:

The Government after careful consideration, accept the proposal of the Principal Chief Conservator of Forests and Chief Wildlife Warden and accord administrative sanction for a sum of Rs.46.90 lakh (Rupees Forty six lakh and ninety thousand only) and release a sum of Rs.44.00 lakh (Rupees Forty four lakh only) under TANII - State Innovation Fund during the year 2018-2019 (Round-I) as annexed to this order.

5. The expenditure sanctioned in para-4 above shall be debited to the following head of account:-

“2406 FORESTRY AND WILDLIFE. 02 Environmental Forestry and Wildlife. 110 Wildlife Preservation. State's Expenditure – JP Establishment of Orchidarium in Anamalai Tiger Reserve under State Innovation Fund – 09 Grants-in-Aid – 03 Grants for Specific Schemes

(ii). The Expenditure shall be met from the State Innovation Fund by deducting under the following head of account:-

And Contra – debiting the following fund account :-

6. Necessary funds are provided in the Budget Estimates 2018-2019.
