ORDER:

The following project of Tamil Nadu Agricultural University has been approved by the State Planning Commission under Tamil Nadu Innovation Initiatives (TANII) for the year 2018-2019 (Round -II) at a total cost of Rs.183.00 lakh for a period of two years:-

“Pilot Plant for upscaling Extraction of Bioactive molecules from Medicinal Plants for Exploitation in Food and Health Industry”.

2) The main aim of the project is to develop bioactive rich herbal products in eco-friendly way to realize the full potential of plant therapeutic/functional food for commercialization to meet food and health industry demand in the domestic and global market. The Project involves extracting bioactive molecules, characterization of the marker compounds and bioactivity assessment of extracted bioactive molecules towards product development and to assess the product quality for phytochemical stability and microbial load during storage for enhanced shelf life.

3) The Registrar, Tamil Nadu Agricultural University has, therefore, requested the Government to issue necessary orders for administrative approval for the implementation of the project viz., Pilot Plant for Upscaling Extraction of Bioactive molecules from Medicinal Plants for Exploitation in Food and Health Industry at a total cost of Rs.183.00 lakh for a period of two years (2019-20 and 2020-21) and also requested to release a sum of Rs.179.00 lakh towards implementation of the scheme for the first year 2019-2020.

4) The Government, after careful examination, accept the request of the Registrar, Tamil Nadu Agricultural University and accord administrative approval for implementation of the project viz., Pilot Plant for Upscaling Extraction of Bioactive molecules from Medicinal Plants for Exploitation in Food and Health Industry at a total cost of Rs.183.00 lakh for a period of two years (2019-20 and 2020-21) and also financial sanction is accorded for a sum of Rs.179.00 lakh (Rupees one hundred and seventy nine lakh only) as first year release for implementation of the above scheme under TANII Project for the year 2018-19.

5) The amount sanctioned in para 4 above shall be debited under the following Head of Account:-

7) Necessary additional funds of Rs.175.00 lakh will be provided in Revised Estimate/Final Modified Appropriation 2019-2020. Pending provision of such funds, the Joint Director of Agriculture, Coimbatore is authorized to draw the amount sanctioned in para 4 above and disburse the same to the Tamil Nadu Agricultural University. However, the expenditure shall be brought to the notice of the Legislature by **Specific Inclusion** in the Supplementary Estimate 2019-2020. The Registrar, Tamil Nadu Agricultural University is directed to include this expenditure while sending the Budget Proposal for Revised Estimate/Final Modified Appropriation 2019-20 and also to send necessary draft explanatory notes for including the above said expenditure in the Supplementary Estimates 2019-2020 to Government in Finance (BG-I/Agri) Department at the appropriate time without fail.

8) The Registrar, Tamil Nadu Agricultural University is directed to follow the existing Finance procedures/Government orders while incurring the expenditure under each item from the amount sanctioned in para 4 above. He is also directed to inform the progress of the work and expenditure made every month to Government.
