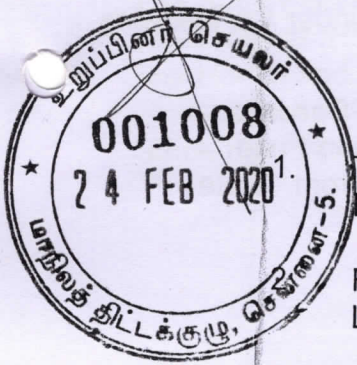

ORDER:-

In the reference first read above, the State Planning Commission has, among others, recommended for establishment of the Therapeutic Park in District Early Intervention Centres (DEIC) at Government Dharmapuri Medical College Hospital, Government Coimbatore Medical College Hospital and Government Annal Gandhi Medical College Hospital, Trichy at a cost of Rs.42.00 lakh through TANII funds for the year 2019-2020.

2. Based on the above recommendation, the Mission Director, National Health Mission in the reference second read above, has forwarded a proposal and requested the Government to accord administrative and financial sanction for the establishment of the Therapeutic Park in District Early Intervention Centres (DEIC) at Government Dharmapuri Medical College Hospital, Government Coimbatore Medical College Hospital and Government Annal Gandhi Medical College Hospital, Trichy at a cost of Rs.42.00 lakh through TANII funds for the year 2019-2020.

3. The Government, after careful examination of the proposal of the Mission Director, National Health Mission hereby accord administrative and financial sanction permitting the Mission Director, National Health Mission

- i) for establishment of the Therapeutic Park in District Early Intervention Centres (DEIC) at Government Dharmapuri Medical College Hospital, Government Coimbatore Medical College Hospital and Government Annal Gandhi Medical College Hospital, Trichy at a cost of Rs.42.00 lakh (Rupees Forty two lakh only) at Rs. 14.00 lakh per centre and

- (ii) to release the amount to the concerned institutions and carry out the civil works through the concerned Head of the Institutions at Rs.14 lakh per center by following codal procedures as per the specification provided by National Health Mission.

4. The amount sanctioned in para 3 above shall be met from the State innovation fund and debited to the following head of account :-

"2210-Medical and Public Health – 01 – Urban Health Services – Allopathy – 110 Hospital and Dispensaries – State's Expenditure – LZ – Setting up of Therapeutic Park at District Early Intervention Centers under State Innovation Fund – 317 Minor Works – 01 Minor Works – Rs.42.00 Lakhs".

5. The above expenditure shall be adjusted by deducting under the following head of account.

"2210-Medical and Public Health – 01 – Urban Health Services – Allopathy – 902. Deduct Amount met from State Innovation Fund – State's Expenditure – JB. Deduct – Amount met from State Innovation Fund – 330. Inter-Account Transfers"

6. By contra debiting from

"J. – Reserve Fund (b) Reserve Funds not bearing Interest – 8229-00. Development and Welfare Funds – 200. Other Development and Welfare Funds- BE. State Innovation Fund"

7. The Mission Director, National Health Mission – Tamil Nadu is authorized to draw and disburse the amount sanctioned in para 3 above.

8. Necessary funds have been provided in Second Supplementary Estimates 2019-2020/Revised Estimate 2019-2020.

9. The Mission Director, National Health Mission – Tamil Nadu / the Project Director, Reproductive Child Health Project shall be the Estimating, Reconciling and Controlling Authority for the New Head of Account mentioned in para 4 above. The Pay and Account Officer / Treasury Officer concerned is requested to open the new Head of Account in their books.
