ORDER:

In the letter first read above, the Industries Commissioner and Director of Industries and Commerce has sent proposal for setting up of Laboratory and purchase of new equipments at an estimated total cost of Rs. 32.50 Lakh for Snake venom extraction project of Thiruvannamalai District Irula Snake Catchers livelihood Industrial Cooperative Society Limited. The following equipments are required for the Snake Venom extraction project.

2. As the society does not have sufficient funds of its own to purchase the above instruments at a total cost of Rs.32.50 lakh, the Industries Commissioner and Director of Industries and Commerce has requested the Government to sanction financial assistance under State Innovation Fund Scheme.

3. Accordingly the above proposal was placed in the Tamil Nadu Innovation Initiatives meeting held at State Planning Commission.

4. Based on the approval letter, received from the Additional Chief Secretary/ Member Secretary, State Planning Commission second read above, the Government accord sanction for a sum of Rs.32,50,000/- (Rupees Thirty two lakh and fifty thousand only) for setting up of Laboratory and Purchase of new equipments for venom extraction to Irula Snake Catchers livelihood Industrial Cooperative Society Limited, Thiruvannamalai District under the Tamil Nadu State Innovation Fund for the year 2019-2020.

5. The Expenditure sanctioned in para 4 above shall be debited to the following head of the Account:
