ORDER:-

The Hon'ble Minister, Social Welfare and Nutritious Noon Meal Programme has made the following announcement on the floor of Tamil Nadu Legislative Assembly while moving demand for grants of Social Welfare and Nutritious Programme for the year 2020-2021:-

“தஞ்சாவூர், கடலூர், திருவண்ணாமலை மாவட்டங்களில் உள்ள அங்கன்வாடி மையங்களில் பதிவு செய்துள்ள கர்ப்பிணிப் பெண்களில் இரத்த சோகை குறைபாடுடைய கர்ப்பிணிப் பெண்களுக்கு சிவப்பு அவல், வெல்லம் கலந்த கலவை ரூபாய் 89.81 லட்சம் செலவில் வழங்கப்படும்”.

2. In the letter second read above, the State Planning Commission, Chennai has recommended to carryout Anaemia Intervention Programme for Ante Natal Mothers in three districts viz., Cuddalore, Thanjavur and Thiruvannamalai at the cost of ₹ 89.81 lakh.

3. Based on the approval of the State Planning Commission, the Director cum Mission Director, Integrated Child Development Services has sent proposal in her letter second read above stating that ante natal women are provided ante natal care and nutrition, education along with 165 gms of Sathu Mavu per day through Integrated Child Development Services for their safe child bearing and healthy child birth. Still there is prevalence of anaemia among mother and child. Hence it is vital to break the vicious cycle by concentrating on the better nutrition of pregnant women and enlighten them on the importance of micronutrient intake.

4. The Director cum Mission Director, Integrated Child Development Services has stated that the Red Rice Flake mix will be prepared and supplied by the Weaning Food Manufacturing Women Co-operative Societies functioning under the control of the Director cum Mission Director, Integrated Child Development Services in the concerned or nearby districts of the project implementation area. The Red Rice Flake Mix will be given as Take Home ration during their ante natal check up twice in a month at the Anganwadi Centre. The pregnant women will also be educated about the importance of its effective consumption.

5. In order reduce the iron deficiency among the pregnant women, the Director cum Mission Director, Integrated Child Development Services has requested to sanction a sum of ₹ 89,81,000 (Rupees eighty nine lakh and eighty one thousand only) towards procurement of Red Rice Flake Mix of 100 gram (i.e 60% Red Rice, 20% Roasted Bangal gram and 20% Jaggery) per beneficiary per day through Weaning Food Manufacturing Women Co-operative Societies functioning under the control of the Director cum Mission Director, Integrated Child Development Services and supply to Anaemic pregnant women in their 1st trimester & registered in the Anganwadi Centres in the three districts viz., Cuddalore, Thanjavur and Thiruvannamalai districts from April 2020 to September 2020.

6. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government issue following orders:-

- i. Sanction is accorded for a sum of ₹ 89,81,000 (Rupees eighty nine lakh and eighty one thousand only) towards procurement of Red Rice Flake Mix of 100 gram (i.e 60% Red Rice, 20% Roasted Bangal gram and 20% Jaggery) Red Rice per beneficiary per day through the Weaning Food Manufacturing Women Co-operative Societies functioning under the control of the Director cum Mission Director, Integrated Child Development Services and supply to Anaemic pregnant women in their 1st trimester & registered in the Anganwadi Centres in the three districts viz., Cuddalore, Thanjavur and Thiruvannamalai Districts from April 2020 to September 2020.
- ii. The Director cum Mission Director, Integrated Child Development Services is permitted to authorize the District Project Officers to submit indent for Red Rice Flakes Mix with the Weaning Food Manufacturing Women Co-operative Societies in the concerned or nearby districts of the project implementation area.

- iii. The Director cum Mission Director, Integrated Child Development Services is permitted to authorize the District Project Officers concerned districts viz., Cuddalore, Thanjavur and Thiruvannamalai to draw and disburse the amount sanctioned in para-6(i) above.
- iv. The Director cum Mission Director is permitted to select the Weaning Food Manufacturing Women Co-operative Societies from which the required quantity of Red Rice Flakes Mix is to be Procured and supplied to anaemic pregnant women.
- v. The District Project Officers of the concerned districts viz., Cuddalore, Thanjavur, and Thiruvannamalai is permitted to settle the bills to the Weaning Food Manufacturing Women Co-operative Societies towards the supply of Red Rice Flake Mix to Anaemic pregnant women registered in the Anganwadi Centres in the three districts viz., Cuddalore, Thanjavur and Thiruvannamalai Districts from April 2020 to September 2020.

7. The amount sanctioned in para 6(i) above shall be met from the State Innovation fund and debited to the following head of account:-

"2236 Nutrition – 02 Distribution of nutritious Food and beverages – 101 Special Nutrition Programmes – State's Expenditure JT Anemia Intervention Programme for Ante Natal Mothers – Scheme under State Innovation Fund – 367 Feeding Dietary Charges – 09 Others".

8. The above expenditure shall be adjusted by deducting under the following head of account:-

"2236 – Nutrition – 02 Distribution of nutritious food and beverages – 902 Deduct – Amount met from State Innovation fund – State's Expenditure – JA Deduct – Amount met from State Innovation Fund – 330 Inter Account Transfers 01 – Inter Account Transfers".
