ORDER:

The Hon'ble Minister (Fisheries and Personnel and Administrative Reforms) has made the following Announcement on the floor of the Legislative Assembly on 01.06.2018.

“பழுவேற்காடு ஏரியில் மீன்வளத்தை அதிகரிக்க செயற்கைப் பவளப்பாறைகள் 8 கோடியே 30 இலட்சம் ரூபாய் செலவில் அமைக்கப்படும்”.

2. In the letter first read above, the Registrar, Tamil Nadu Dr.J Jayalalithaa Fisheries University has requested the Government to forward the project proposal entitled on "Artificial Coral Reef (ACR) and Fish Aggregating Artificial Reef (FAAR) to Enhance Fish Diversity and Biomass in the sea near Pulicat Lake towards Fishing Pressure Reduction and Livelihood Improvement of Fisherfolk in the Lake Region" with budget outlay of Rs.830.00 lakh to the State Planning Commission for funding support under Tamil Nadu Innovation Initiatives (TANII) project for the year 2018-19.

3. In the letter second read above, the State Planning Commission, Tamil Nadu Innovation and Initiatives (TANII) has directed the University to downsize the total budget of Rs.830.00 lakh to Rs.580.66 lakh.

4. In the letter third read above, the Registrar, Tamil Nadu Dr.J Jayalalithaa Fisheries University has furnished the revised Detailed Project Report on the above proposal at a cost of Rs.580.66 lakh for funding support under Tamil Nadu Innovation and Initiatives (TANII) for the year 2019-20 (2nd round) and requested the Government to issue necessary orders for a sum of Rs.580.66 lakh for implementation of the above scheme.

5. In the letter fourth read above, the Member Secretary, State Planning Commission has recommended the proposal by excluding Rs.1.50 crore for Building from the total project cost of Rs.5.81 crore and the commitment under Tamil Nadu Innovation and Initiatives (TANII) is Rs.430.66 lakh.

6. Based on the above recommendation of the State Planning Commission, the Government has decided to accord sanction for a sum of Rs.301.72 lakhs (Rupees three crore one lakh and seventy two thousand only) for the year 2019-20, Rs.107.22 lakhs for the year 2020-21 and Rs.21.72 lakhs for the year 2021-22 for Implementation of the Scheme on "Artificial Coral Reef (ACR) and Fish Aggregating Artificial Reef (FAAR) to Enhance Fish Diversity and Biomass in the sea near Pulicat Lake towards Fishing Pressure Reduction and Livelihood Improvement of Fisherfolk in the Lake Region under Tamil Nadu Innovation Initiatives (TANII) Project (Round-II) for the year 2019-20.

7. (i) The expenditure sanctioned in para-6 above shall be debited to the following head of account:-
