In the letter first read above, the Member - Secretary, State Planning Commission has informed that the shelf of schemes viz., Development of semi and fully Automated Intelligent Exo-skeletal and Prosthetics for Disabled Communities and Converting inert wastes into Bioamendments / Biofertilizers – Pilot Projects at Legacy Wastes Dumping Site in Tamil Nadu have been recommended for 2020 – 21 (Round – I) by the State Planning Commission and in the letters 2nd read above the Registrar, Anna University has sent the detailed project proposal and year wise expenditure for the above scheme. 2. The Registrar, Anna University has requested the Government to sanction the first year grant for the implementation of said projects.

3. The Government after careful consideration, sanction a sum of Rs.4,15,10,000/- (Rupees four crore fifteen lakh and ten thousand only) for the scheme of "Development of Semi and Fully Automated Intelligent Exo-Skeletal and Prosthetics for Disabled Communities" and a sum of Rs.18,38,000 (Rupees eighteen lakh thirty eight thousand only) for the scheme of "Converting Inert Wastes into Bioamendments / Biofertilizers –Pilot Projects at Legacy Wastes Dumping Site in Tamil Nadu" under State Innovation Fund, to Anna University, Chennai as the first year grant for the year 2020 – 21 from the provision made in Budget Estimate 2020 -21.

4. The expenditure sanctioned in para 3 above shall be debited under the following head of accounts:-

5. The above expenditure shall be met from the State Innovation Fund by deducting under the following head of account:-

6. The Director of Technical Education is authorized to draw and disburse the amount sanctioned in para 3 above to Anna University, Chennai.
