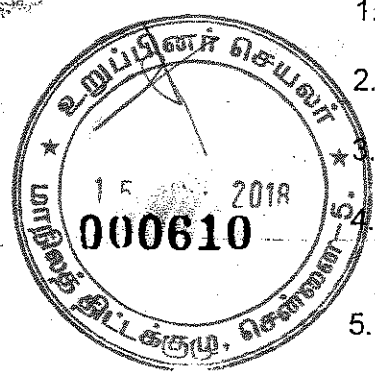
**ORDER:**

2. The State Planning Commission has recommended two proposals of the Principal Resident Commissioner, Tamil Nadu House, New Delhi for assistance under TANII, (i.e) (i) Provision of Intelligent Door Lock System integrated with hospitality Management System, (ii) Provision of Airplus Coating Solution for Air Pollution Control for the year for the year 2017 – 18 (Round II). The State Planning Commission has also requested to issue necessary sanction as per the guidelines and procedures prescribed in the reference first and second read above after obtaining the detailed proposals from the Head of Departments.
