### ORDER:

In the letter first read above, the State Planning Commission has recommended for modernization of the Sales Counters of the Madurai Khadi Kraft at a cost of Rs.80.00 lakh under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2017-2018.

2. In the letter second read above, the Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board has stated that the Hon'ble Minister for Khadi and Village Industries had announced in the floor of the Assembly on 29.06.2017 that with a view to improve the sales of Khadi and Village Industries Products, the existing Khadi Kraft at Madurai will be renovated with modern facilities as 'Khadi Mart' at a cost of Rs.80.00 lakh. Accordingly, detailed estimates for Rs.80.03 lakh along with work plan for carrying out the above said renovation of the

'Khadi Kraft' sales outlet at Madurai has been obtained from the Chief Engineer, Tamil Nadu Police Housing Corporation and the same is enclosed. Hence, the Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board, has requested the Government to sanction the fund and permission to execute the work through Tamil Nadu Police Housing Corporation to enable the Board to accord Administrative sanction to the Tamil Nadu Police Housing Corporation to commence the work.

3. The Government, after careful examination of the proposal of the Tamil Nadu Khadi and Village Industries Board sanction a sum of Rs.80,00,000/- (Rupees Eighty lakh only) for the Renovation / Modernisation of 'Madurai Khadi Kraft' under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2017-2018.

4. The expenditure sanctioned in Para 3 above shall be met from the State Innovation Fund and debited to the following head of account:-

2851-00. Village and Small Industries - 105. Khadi and Village Industries - State's Expenditure -KH. Modernisation of the Sales Counters of the Madurai Khadi Kraft - Scheme under State Innovation Fund - 09. Grants-in-Aid-03. Grants for Specific Schemes.


