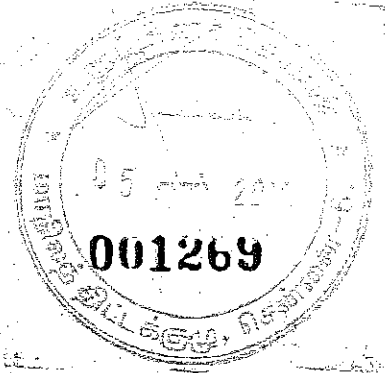

Order:

In the letter first read above, the Member Secretary, State Planning Commission has informed the Government that the State Planning Commission under TANII 2017-18 have recommended and sanctioned Rs.165.32 lakh to administer Pneumonia Vaccine to elderly persons in Senior Citizen Homes and Integrated Complexes run by NGO's with State and Central Grants and requested the Government to issue necessary sanction as per the guidelines and procedures prescribed in the G.O.Ms.No.124, Planning Development and Special Initiatives (SP.1) Department, dated 24.10.2014 and G.O.Ms.No.153, Planning Development and Special Initiatives (SP.1) Department, dated 23.12.2014 duly obtaining detailed proposal from the Heads of Departments and a copy of the Government Order issued be marked to State Planning Commission also.

2. Accordingly, the Director of Social Welfare has sent the detailed proposal to the Government wherein she has informed that the State and Central Government are taking various welfare measures for care and protection of older persons and also established Old Age Homes / Integrated Complexes for Destitute Children for providing food, health care & shelter to the abandoned.

and destitute older persons. It is well known fact that even the privileged sections of the older persons will have many health problems due to their vulnerability of deteriorations health condition because of ageing. The elderly are already given a lot of medicines for their chronic diseases such as Diabetics, Blood Pressure, etc. and some of the elders may also be taking medicines for cancer, heart problems & other serious ailments. However, several ailments such as influenza, pneumonia, Tetanus, Typhoid and Hepatitis B that affect elderly persons may add to their woes but may be prevented through appropriate vaccines that are recommended for protection against these diseases. Vaccines are the best defence against the serious, preventable, and sometimes deadly contagious **Pneumococcal (pneumonia)** diseases which most commonly affects the older persons and hence the vaccine PREVNAR 13 may be administered to such 1853 elders who are given care through the NGOs with State grant and to 2280 elders who are given care through the NGOs with Central grant totalling to 4133 elders. Further, she has stated that the cost of vaccine for the pneumonia disease will be about Rs.3800/- per inmate for vaccine and Rs.200/- for other incidental charges such as storage expenses and other charges. Hence, the Commissioner of Social Welfare has requested the Government to sanction a sum of Rs.1,65,32,000/- (Rupees One Crore Sixty Five Lakh Thirty Two Thousand only) for administration of vaccine to the aforesaid 4133 elderly persons residing in the Old Age Homes/ Integrated Complexes run by NGOs with State grant and the Old Age Homes/ Respite Care Centres/ Multi Service Care Centres / Day Care Centres/ Multi service care centres for Older Widows/ Physiotherapy clinics for older persons run by NGOs with Central grant. The Commissioner of Social Welfare has also requested to permit to withdraw the above amount under Article 99 of Tamil Nadu Financial Code Volume I.

3. In this connection, in order to implement the aforesaid scheme, the Dean, Rajiv Gandhi Government General Hospital, Chennai has been requested to send the detailed guidelines. Accordingly in her letter fifth read above, the detailed guidelines have been sent to the Government after perusing the minutes of the meeting convened by the Director of Public Health and Preventive Medicine in the letter fourth read above in the above matter.

4. The Government carefully examined the above matter alongwith the guidelines for implementing the aforesaid scheme issue orders as follows:-

- i. A sum of Rs.1,65,32,000/- (Rupees One crore sixty five lakh and thirty two thousand only) is hereby sanctioned for administration of vaccine to the eligible and medically indicated 4133 elderly persons residing in the Old Age Homes / Integrated Complexes run by NGOs with State grant and the Old Age Homes / Respite Care Centres / Multi Service Care Centres / Day Care Centres/ Multi Service care centres for Older Widows / Physiotherapy clinics for older persons run by NGOs with Central grant. The details are given in the Annexure I.
- ii. The Vaccination shall be procured by the Commissioner of Social Welfare through Tamil Nadu Medical Services Corporation.

- iii. The Commissioner of Social Welfare shall give the details of Old Age Homes and the number of inmates to the Director of Public Health to plan for the Vaccination Programme.
- iv. The detailed guidelines for implementation of the aforesaid vaccination / Immunisation scheme is given in Annexure-II.
- v. The Commissioner of Social Welfare is permitted to draw and disburse the sum of Rs.1,65,32,000/- (Rupees One crore sixty five lakh thirty two thousand only) under Article 99 of Tamil Nadu Financial Code Volume I.

5. The amount sanctioned at para 4(i) above shall be debited to following Head of Account:-

ANNEXURE-II**G.O.(Ms) No.27, Social Welfare and Nutritious Meal Programme****(SW 6(1)) Department, dated 26.03.2018****Guidelines for Implementing the Immunization Programme for the Elders**

1. Age group: Adults more than 60 years and less than 90 years, since the immune response may not be adequate in the very elderly people (Above 90 years).
2. Preliminary screening of all the inmates of the old age homes should be done by nearby PHC/GH medical officers with regard to previous vaccination, co morbid illness like diabetes, hypertension, COPD, chronic kidney disease, malignancy and current illness like Lower Respiratory infection, Upper Respiratory infection and Acute Diarrhoeal Disease etc.,
3. Day of Vaccination may be fixed two or three days after the screening and the vaccine requirement may be calculated accordingly.
4. Vaccine to be stored in the nearby Primary Health Centre / District Hospitals maintaining appropriate cold chain (2-8 degrees) and should not be frozen.
5. Depending on the requirement, each Primary Health Centre / District Hospitals the vaccine may be procured from central supply.
6. Training or Orientation meeting to the Medical Officers and the Vaccinators of the RBSK and Urban Primary Health Centres team will be conducted by Department of Public Health and Preventive Medicine.
7. The District Social Welfare Officer will co-ordinate with the Health Department official at district level.

(P.T.O)

Mode of Administration

1. Vaccine should be administered by trained Nurse under the supervision of Medical Officer following aseptic techniques along with AEFI Kit. Emergency medicines include inj.Efcorline, inj.atropine, inj.adrenaline, inj.dexamethasone, inj.chlorhoneramine maleate as per Universal Immunisation protocol.
2. Consent should be obtained from the beneficiary.
3. The pneumococcal conjugate vaccine should be given as intra muscular injection in the deltoid of upper arm in adults.
4. The recipient must be made to sit for ½ hour observation and instructed to report any avertable event.
5. Individual Immunisation card with photo to be prepared and kept in the Old Age Homes for follow up and future immunization. The Health workers should maintain a register with details of the patient and follow up visit one week after vaccination in necessary.
6. In initial phase all inmates will be receiving conjugate vaccine 13 as a single dose. For high risk individuals-Diabetes Mellitus COPD, Cardiac failure, renal failure, malignancy and transplant recipients etc., the Polysaccharide vaccine (PPV23) may be given after one year.
