ORDER:-

In the reference first read above, the State Planning Commission has, among others, recommended for creation of “cGMP facility for Stem Cell Research and Treatment” and “Clinical Trials - Use of Adult Stem Cells in Patients with End-Stage Liver Disease” at Institute of Surgical Gastroenterology and Liver Transplantation, Government Stanley Medical College and Hospital, Chennai.
